ORDER

As per the notification and circular read as Ist and IInd paper above, the Chief Superintendents of DCA Exam Centres were directed to workout the expenses of DCA (practical and main) examination and furnish proposal for advance to this office. Advance for 39 exam centres out of 55 has already been sanctioned as per the proceedings read as 4th above. Now the remaining Chief Superintendents of 16 exam centres have furnished their proposal for advance. The proposals of 16 exam centres were verified and amount of advance to each exam centres was ascertained based on the norms under notification read above. Total amount of advance to 16 exam centres comes to Rs. 194055/- (One lakh ninety four thousand and fifty five only) as per the list attached.

Sanction is therefore accorded to draw an amount of Rs. 194055/- (One lakh ninety four thousand and fifty five only) from the Head of account "Conduct of Examination of DCA Course" of KSOS budget 2015-16 and disburse as advance to 16 Chief Superintendents DCA exam centres as per the list appended for meeting the expenses of DCA (practical and main) examination 2015.

The Chief Superintendents of exam centres will furnish proper vouchers, acquittance etc within a week after the DCA main examination is over for settlement of advance.
